Eligibility

1

- The competition shall be open to students who are pursuing an integrated 5-year LL.B. program or pursuing a 3-year LL.B. program from recognized University/Institution approved by Bar Council of India.
- Each team shall consist of 3 members, (two 'Speakers' and one 'Researcher') or 2 members (two 'Speakers' and out of these two, one speaker has to be designated as a researcher as well). Maximum of 3 members and minimum of 2 members in a team are allowed.
- Only one team from any College/Law School/University is allowed to participate in the Competition.
- No additional member or team coach is allowed to accompany the team.

Submission of Memorials

- Participants have to send the soft copy of the Memorials, one from the Petitioner and one from the respondent side (both in Word (.docx/.doc) and PDF format).
- O Soft Copy of the memorials shall be sent to the given mail id: mootcourt@apexuniversity.co.in with the subject "Memorials for Team Code". The file names of the electronic copies of the Memorials must contain only the team code and

the side being represented in the following format: e.g. (for Team Code TC08): TC08 (P) or TC08(R). The content of the memorials should not differ from the content of the soft copies submitted to the Organizers. The last date to send the soft copy of the memorial is February 20, 2024 by (23:59 hours IST).

- Last date for receiving of hard copies of each of the memorial for all participants will be February 28, 2024 by (23:59 hours IST).
- The teams must send Four Hard Copy (2 Petitioners & 2 Respondents) of their Memorials from each side to the following address-: Dean, Apex School of Law, Padmani VT Rd, Ward 27, Mansarovar Sector 5, Mansarovar, Jaipur, and Rajasthan, India 302018.
- O Identification mark of any type shall attract a severe penalty.
- The copies of the memorials must bear cover page in conformity with the following scheme:

- No amendment to the memorial will be permitted after submission. Teams are not permitted to raise arguments in the oral rounds that are not present in the memorial.

- O Each memorial shall consist of the following details on the cover page :
 - 1. Team code on the top right-hand corner of the cover page. Memorials without the team code will not be evaluated.
 - 2. Name and place of the forum.
 - 3. Name of the parties and their status.
 - 4. Memorial filed and the party that the team is appearing on behalf of the following content specification must be adhered to :

- 1. Language English
- 2. Font and Size (Body) Times New Roman, 12 pts
- 3. Line spacing (Body) 1.5 lines
- 4. Font and Size (Footnotes) Times New Roman, 10 pts
- 5. Line Spacing (Footnotes) Single Line
- 6. Page Margins 1 inch on all sides





- 7. Paper Specification White A4 Sized Paper
- 8. Body of the Memorial /Justified
- 9. Citation style Bluebook (20th Edn.)
- The memorial shall not be of more than fifty (50) pages and the Arguments advance shall not exceed more than thirty (30) pages.
- The Memorial must be spiral bound ONLY. The Memorial must not contain any Annexure/Photographs/Sketches/Exhibits/Affidavits etc.

Awards

- □ Winning Team Award: The winning team will get a trophy and certificate of appreciation with a cash prize of Rs. 21,000/- with 1year Subscription of EBC Learning
- Runners-Up Award: The runners-up will get a trophy and certificate of appreciation with a cash prize of Rs. 11,000/- with 1 year Subscription of EBC Learning
- Best Memorial: Best Memorial will get a trophy and certificate of appreciation with a cash prize of Rs. 5100/-
- Best Speaker: Best Student speaker will get a trophy and certificate of appreciation with a cash prize of Rs. 2100/- with 6 Months Subscription of EBC Learning
- Best Researcher: Best Researcher will get a trophy and certificate of appreciation with a cash prize of Rs. 2100/- with 6 Months Subscription of EBC Learning
- Certificates of participation shall be given to all the participants along with 1 Month Subscription of EBC Learning.
- The participation certificates will not be provided to any participant who is not present at the Prize Distribution Ceremony and the same shall not be sent by post/courier to participants under any circumstances.





Accommodation

- The organizers will provide boarding and lodging facilities.
- Any misconduct at the venue or the place of accommodation shall result in disqualification of the team from the accommodation.

Dress Code

Inside the court room the participant shall follow the below mentioned dress code.

- **Females :** White salwar kurta & Dupatta or white shirt and black trousers along with black coat and tie.
- Males : white shirt, black trousers, black tie along with black coat and Black shoes.

Competition Rounds

There shall be two preliminary rounds, quarter finals, semifinals and a final round spreading over a period of 3 days.

Preliminary Rounds

- There shall be two Preliminary rounds. In the two Preliminary Rounds, the Participating teams shall argue for both the sides. The team which argues from one side in the first preliminary Round shall argue from another in the second Preliminary Round.
- The pairing of teams for the Preliminary Rounds shall be done by a draw of lots by the competition Organization Committee. No two teams shall argue against each other more than once in the Preliminary Rounds.
- Each Team will be given the opposing team's Memorials after the draw of lots. No team shall be provided any information regarding the identity of the opposing teams or any other team participating in the Competition.





- The selection of the top 8 teams for the Quarter Final Rounds shall be based on total number of wins as well as the 'total scores' of teams after conclusion of both the Preliminary rounds. The selection shall be based on the following criteria :
 - ➤ First, the team with the higher total score after the two preliminary rounds shall be ranked higher. While deciding the Quarter finalists the wins secured by teams in both rounds will also be taken into consideration along with the scores, such that, the team with 2 wins in the preliminary rounds will be ranked higher than the team with a single win.
 - Second, for teams that have the same total round score and wins in the preliminary rounds, the team with the higher aggregate absolute speaker scores shall be ranked higher.
 - Lastly, if two teams have the same total round score, same wins and the same aggregate absolute speaker scores in the preliminary rounds, then the team with the higher memorial scores shall be ranked high.

Quarter Finals

- In the Quarter-Final, each Participating Team shall be assigned to argue for one side i.e., each team shall argue only once against the team determined by and for the side decided by a draw of lots.
- O Each Team will be given the opposing team's Memorials after the draw of lots.
- No team shall be provided any information regarding the identity of the opposing teams or any other team participating in the Competition.
- It shall be a knockout round. The winner of each round shall move to the semifinal. Four (4) teams shall move to semi-finals.
- In case of tie between teams, in quarter finals, the aggregate total of the marks of memorials (appellant and respondent) of the teams shall be counted. Team with highest marks moves ahead.





Semi Finals/Final

- O The selection of 4 teams for the Semi-Final Round and of 2 teams for the Final Round shall be on a 'knock-out' basis.
- O Four (4) teams shall compete in semifinals. It shall be a knock out round. The winner of each semifinal round shall move to the Final round.
- The criteria of marking in this round are aggregate total of the marks of both the speakers.
- In case of tie between teams, in semifinals, the aggregate total of the marks of memorials (appellant and respondent) of the teams shall be counted. Team with the highest marks moves ahead.
- There shall be one (1) FINAL ROUND. The marking criteria in Final Round is the same as that of semi-finals.

Important Note : In all cases, decision of the Judges organizers shall be final and abiding.





MOOT PROPOSITION

CYBER/HUMAN RIGHTS APPLICATION NO. 01 OF 2024

IN THE MATTER OF:-

MOOT PROBLEM

FACTS : -

That case originated vide application bearing No. Cyber/Human Rights Application No. 1 of 2024 against the Republic of Frenchlands (hereinafter referred as "the State") under the "Convention for the Protection of Human Rights and Fundamental Freedoms" (hereinafter referred as 'the Convention") by an Frenchlands national on 01.01.2024.



The applicant alleged, in particular, that her rights under the Convention had been breached, owing to the authorities' failure to protect her from unjustified instructions into her private life linked to her work as journalist. The applicant worked as an investigation journalist at Frenchlands Radio Station whose broadcasts were often critical of the government covering corruption, favoring top industrialist, violation of labour rights, promoting own government party people etc. Before the events giving rise to the present case, the applicant had broadcast and published an article concerning the alleged involvement of the Home Minister and Defense Minster sons in various illegal mergers/ventures which resulted into violation of human rights of labour and other bidders to procure the mining tenders. The applicant uncovered that the Home Minister and Defense Minister family controlled a mining consortium in various province of the country which had just been awarded a lucrative licence by the Frenchlands government. The applicant continued broadcast and published articles against the Home Minister and Defense Minster family in regard to benefits from various sources in the mining matters. According to the applicant, since she began reporting critically on the ruling government of the Frenchlands she has been threatened and intimidated in various ways.

That on 01.10.2023 the applicant received a letter enclosing images and videos taken in her bedroom with a hidden camera where the applicant engaged in sexual intercourse with a man who, according to her was her then boss son. The letter had been sent by the speed post from an address in Disney land where Home Minister son was settle for business expansion. The sender's name noted as "John". The applicant also received letter accompanying the images stated: "BOLD, WILD ON BED, WHORE, REFRAIN WHAT YOU ARE DOING, OTHERWISE YOU WILL BE SHAMED! []"

That on 10.10.2023 applicant reported the above-mentioned letter to prosecution authorities and requests to lodge a formal investigation, stating that above-mentioned incident amounted to blackmail related to her recent journalistic activities and also requested measures to protect her safety. As per the applicant information images and videos were also sent to other broadcast companies to defame to the applicant in her fraternity. The applicant also made a strong statement at various social platforms that she would not cease her journalistic activity and would not be silenced. On 01.11.2023 a video was posted online on a website named "Oppostion/party/contribution-for public.in" featuring scenes of a sexual nature involving the applicant with her boss son. Opposition political party indicated that it had nothing to do with the website and condemned the nd Dr. S.M. Juniwal

posting of the video. On 10.11.2023 another video purporting to show the applicant engaged in sexual activities was posted on a aforesaid website where, according to the applicant, similar videos of other activists and anti-government figures had been posted previously. As per the applicant, this particular video which was posted on 10.11.2023 did not in fact involve the applicant, but rather a woman meant resemble her. The applicant also stated that she alongwith the broadcast channel was criticised for lack of professionalism and anti-government. Moreover, citing former employees, it was insinuated that the applicant was a person of immoral behavior who spent a great deal of her time in bars and clubs and regularly held all night-parties and "orgies" with her friends and boss son in her office. According to the applicant the domain mentioned hereinabove was apparently chosen solely for the posting of her private sexual videos with her boss son.

Status Report in civil proceeding against the prosecuting authorities:-The status report noted that the applicant and her lawyer had been spreading false information in the media about the alleged inadequacy of the investigation and, as such, had attempted to "create a negative opinion" among the public concerning the investigation which is not related to only the applicant dignity but that in regard to safety of the entire women community of the Frenchlands.

Status Report in Criminal proceeding against the applicant:- The applicant was arrested and detained on the charge that she had incited a former colleague to commit suicide, additionally charges with the criminal offences of large-scale misappropriation, illegal entrepreneurship, large-scale tax evasion and abuse of power in connection with her activity at broadcast channel being senior journalist.

On 15.12.2023 the applicant was sentenced to 10 years of imprisonment. After a series of appeal upto to the apex court she was acquitted in part and her sentence was reduced to 5 years imprisonment. Being aggrieved by the judgments and investigation conducted against her due to influence of the ruling government and to harass her for raising her voice for the welfare of the Frenchlands public, the applicant approach the International Human Right Commission for the justice.

Parties are required to advance the arguments on domestic and international laws (Arguments includes procedural aspect, convention, treaties, domestic criminal and civil law) Dr. S.M. Juniwal Ranka International Moot Court Competition



Researcher of both the parties have to submit the legal report with respect to situation mentioned hereinabove in the moot problem from the both side as amicus curiae covering international and domestic law aspect.

- Participants are requested to argue on the side of the Applicant as well as on the side of the Respondent before the "Hon'ble Court of International Human Right Commission" pertaining to the above case and further elucidate the arguments with appropriate case laws and inputs.
- The laws of Republic of Frenchlands are pari material with laws of India. The Republic of Frenchlands considers the leading common law precedents as being highly persuasive. Hence, all the relevant ancient, modern, texts of Indian law may be referred for arguing the case.
- This Moot Problem has been formulated solely for the purpose of this competition for furthering the academic exercise only.
